- Speed Complaint SC1510080 Aislaby to Egton Road: Update on CSW Scheme and to decide on Highways suggestion of GiveWay sign: Clerk advised that a CSW scheme was possible and she had asked for an article to be placed in the Parish Magazine. NYCC Highways had advised that roundels had been found not to be effective, have maintenance implications and not something would use on this road; however, the option to have a Giveway sign sited 1.5m from the junction was possible, but this would be adjacent the War Memorial. Other suggestions by Cllrs made, but Clerk advised this was the only option on offer. RESOLVED not to ask NYCC Highways to install the Giveway sign as would impede the aesthetics of the war memorial.
