The following issues were raised:

### 7 REPORT ON MATTERS ARISING FROM PREVIOUS MEETING

The following ongoing issues were discussed and decided upon:

- a. Footpath Selly Hill signage update: Clerk reported that had been advised NYMNPA will arrange for a waymark post to be installed
- b. Featherbed Lane overgrown update: Chased but no further. Cllr DP provided a photo of the state of Featherbed Lane footpath. Noted that hedges responsibility of landowner. Cllr DP to pass photo to the Clerk to forward

### 10 PARISH MAINTENANCE

The following were discussed and decided upon:

a )Ongoing Maintenance of Public Toilets:

i) Cllr RD to update on any maintenance repairs undertaken or required: None b) Monitoring of Footpaths: Cllr DP to report on any issues relating to footpaths within the parish boundary and decide if any action to take: None apart from previously mentioned Featherbed Lane.

*c)* Toft Corner – verge damage: update report on potential verge markers: Noted that NYCC had installed verge markers and it was hoped this would alleviate potential damage to the trods.

d) Parking on Village Green – to discuss and decide on how to deal with: RESOLVED that the Clerk obtain prices for 3 A4 signs to be placed on the village green – black ink on white background and potential to be reflective. To say "Village Green – Please No Parking – Aislaby Parish Council".

e) Affordable Housing – to discuss and decide on what further action if any the parish council can take to facilitate Affordable Housing in the village following the ceasing of the previous Broadacre Project: RESOLVED for the clerk to contact to see if any further options to progress the development.

f) Toft Corner Trods – to discuss whether to request NYCC to clean the trods: RESOLVED for the Clerk to contact and ask for the trods to be "cut back" to full original size as disappearing due to overgrowth of grass. Noted that trods have had increased usage due to the caravan sites.

### 11 FINANCE

The following was discussed and agreed upon:

*i)* Payment Schedule: The schedule of payments for October was received, reviewed and members RESOLVED to approve those items listed. Noted no invoice received from G Coulson for grass cutting.

ii) Transfer Monies from Business Bank Instance to Treasurers Account & Closure of Business Bank Instant Account – update report: Noted response from Lloyds Bank had been received stating had not recognised Cllr TH's signature. Clerk had replied with a copy of the bank mandate which clearly showed that both Cllr TH's signatures were exactly the same.

*iii)* Annual Garth Collection: Garth receipt book passed to Cllr K Nellis and noted to be undertaken by Cllr K Nellis in October 2017 for the November 2017 meeting.

*iv)* Review and approve Qtr 2 Financial Statement and associated bank reconciliation and bank statements (*if received*): Following review RESOLVED to approve. Noted that due to no transfer of monies yet that the bank account was low; however, the SBC remittance increased balance.

*v)* SBC Precept/Model Agreement: Noted receipt of remittance for £1075.00 and £890.63 respectively.

*vi)* York Potash: Noted payment instalment remittance received for £163.10

vii) Smith of Derby – Annual Clock Maintenance St Margaret's Church (Model Agreement): To decide if wish to proceed with continuation of 3 year discounted contract at £501 +VAT (ie £167 pa) or annual contract of £181 +VAT. Note receive £157.25 per annum from SBC as part of Model Agreement for Public Clocks: Discussion was held regarding the ongoing costs of the parish council and that spending more than receiving, noted that the

Clerk had already reduced hours to improve costs. It was RESOLVED to write to St Margaret's and advise that because of funding and what receive from SBC Model Monies the parish council could not continue with the amount paying. In addition to advise that perhaps they continue with the contract or go out to tender; however, the parish council would continue to forward the monies received by SBC via the Model Agreement to pay towards the annual service of the public clock.
